2. BEC (Technical) Pg.no 7 of 112. The Criteria is modified as follows:

**A. Technical Criteria:**

The bidder must have successfully completed at least one Single contract/Work order of value not less than 3.0 lacs for Third Party Inspection/ Quality Surveillance of vendor supplied items for Chemical/ Petrochemical/ Hydrocarbon Processing Industry/ Fertilizer/ Power Plant in preceding 5 years prior to final date of bid opening.

The bidder / agency should have successfully completed at least one work of Quality surveillance for cross country oil or gas pipeline laying for Oil or Gas processing Industries

AND

For Steel pipeline networks & MDPE pipe networks for any CGD entities having minimum order value of Rs.3.0 Lakhs (Rupees three lakhs) and above, in previous 5 years (from bid due date).

AND

The bidder must be enlisted by NABCB (National Accreditation Board for Certification Bodies) in list for IB (Inspection Bodies)/QMS (Quality Management Systems). The bidder must also be approved agency by PNGRB.

AND

The bidder must have minimum 10 nos. of employees as quality control engineers with minimum three years of experience in the field of Chemical/ Petrochemical / Hydrocarbon Processing Industry / Fertilizer / CGD / Power Plant since last one year from last date of bid submission. Bidder must submit documentary proof such as appointment letter/ record of PF deduction / copy of salary slip along with list of employees. The bidder must employ minimum 04 nos. NDT Level-II & 01 no. NDT Level-III personnel in any NDT technique (RT/UT/MPI/DPT). The bidder must submit copies of Level-II & Level-III NDT certificate as documentary proof.

AND

The bidder must have site offices in minimum four major cities out of Delhi, Mumbai, Kolkata, Chennai, Bangalore, Hyderabad, Baroda, Coimbatore, Tiruchirapalli, Pune, and Ahmedabad. Bidder must submit documentary proof for address confirmation

AND

Bidder must submit attested copies of relevant detailed work order and completion certificate issued by the end user having the reference number of work order, date of completion and executed value in support of meeting the above criterion.



In case of service contracts awarded for two years and further extension is granted beyond two years, bidders may be qualified on the basis of a certificate issued by EIC indicating that work has been done satisfactorily and documents pertaining to PF contribution of contract workers i.e. 3A and 6A, have been submitted against the contract at least for initial one year of the contract and also provided initial period of contract has been completed before last date of bid opening.

A Job executed by a bidder for its own plant/projects cannot be considered as experience for the purpose of meeting BEC of the tender. However, jobs executed for Subsidiary/Fellow subsidiary/ Holding company will be considered as experience for the purpose of meeting BEC subject to submission of tax paid invoice (s) duly certified by Statutory Auditor of the bidder towards payments of statutory tax in support of the job executed for Subsidiary/Fellow subsidiary/ Holding company. Such bidders to submit these documents in addition to the documents specified to meet BEC.

Experience acquired by a bidder as a sub-contractor can also be considered for qualifying the experience criteria of BEC. In such cases, bidder shall be required to furnish the following documents in support of meeting the "Bid Evaluation Criteria":

Copy of work order along with SOR issued by main contractor.

Copies of Completion Certificate from the end user/owner and also from the main contractor.

The Completion Certificate shall have details like work order no/date, brief scope of work, ordered and executed value of the job, completion date etc.

(Attestation must be done by Gazetted officer/ Officer of PSU/ Notarized by Notary public)

### 3. Schedule of Rates

1. ONE MANDAY = 8 WORKING HOURS

i)TPI Inspector shall plan and work for minimum 4 hrs in a day, as per the direction of EIC, in order to consider the working duration half of the manday rate.


ii) If the working duration is more than 4 hours in a day, will be on pro-rata basis for the actual number of hours logged.

iii) The manday/hourly rate will be the same for all the days of the week (even on holidays)

iv) Extra working beyond 8 hours in a day shall be paid on pro-rata basis for the actual number of hours logged.

2. If any difference between unit price &amp; amount is found, the unit rate quoted by the bidder shall be considered for price evaluation.

3. The rate shall be payable based on the actual work done. The quantity indicated is approximate and any increase or decrease in the quantities will not affect the rates quoted.



4. Basis of evaluation shall be on overall quoted price basis plus all taxes, duties and service tax etc.

5. The Unit Rate quoted by the bidder shall be inclusive of all taxes, duties, levies except Service Tax and Education Cess thereon. The bidder is required to mention the applicable rate of Service Tax and Cess thereon, separately in the SOR as on the final due date of bid submission for evaluation and award purpose. Service Tax and Cess thereon shall be paid as per the rate mentioned by the bidder in their offer maximum to the applicable rate on submission of cenvat invoice(s). In the event of statutory variation on account of Service Tax and Cess thereon within the contract period (except variation on account of turnover), the same shall be to GGPL's account against documentary evidence.

6. Bidders are advised to include the Rebate / Discount, if any, in the unit rate of Schedule of Rates (SOR) itself and NOT to mention the same separately.
